Response: The Putnam County District will take the following actions to involve parents in the joint development of the District-wide parent involvement plan and the LEA plan:

1. Invite parents of Title I students to attend and participate in various Parent Involvement District Advisory Council (PIDAC) meetings. All parents who attend are members of the group. Using the template provided by the Department of Education, the Director facilitates the development of the plan with direct input from the parents.
2. Provide the Title I principals with the District Title I Parent Involvement Plan to be placed on the School Advisory Council (SAC) agenda for parental review. The School Advisory Council members are elected in accordance with individual school's SAC by-laws, but the SAC meetings are advertised and open to all parents. 3. Provide digital and hard copies of the District Title I Parent Involvement Plan to all Title I schools in October of 2013.
4. Provide parents with opportunities for personal meetings during the year.
5. An agenda, sign in sheets and handouts will be provided to validate the meetings and copies will be kept in the Title I audit box.
